CAUCUS MEETING MINUTES

September 30, 2019

The Meeting was called to order by Mayor Forbes.

The flag salute was led by Mayor Forbes

Mayor Forbes announced that the meeting was in compliance with the Sunshine Law.

Council Persons present Walters, Cairns, Egan, Brandley and Lehman. Councilwoman Valianti was not present.

Council went over the Engineer's report with Borough Engineer Greg Fusco.

Motion to open the meeting to the public by Councilman Lehman, seconded by Councilwoman Egan. All in favor- motion carried.

Joe Denella-23 Newton Ave-Feels there should be a stop sign going north on Newton Ave. by the dead end. Mayor Forbes said that he would have the police do a traffic study and see if there is a need for one.

Lisa Casell & Sara-Tinker Garden representatives- Asked if they could use the VFW Park as a meeting spot for their Tinker Garden Group. They would meet weekly in the park with parents and children. It was explained that they would just need to get proof of insurance for the group to meet in the park.
